#ProShopPrizeDay Sweepstakes - 2/24/21

Official Rules

1. <u>General</u>. By submitting an entry to this Sweepstakes, sponsored by the Boston ProShop ("the Sponsor"), the entrant acknowledges and agrees to all of these Official Rules. Void where prohibited. Sweepstakes begins at 8:00 a.m. Eastern Time on Wednesday, Feb. 24, 2021 and ends at 5:00 p.m. Eastern Time on Wednesday, Feb. 24, 2021 ("the Sweepstakes Period"). By entering the drawing, entrants agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are in its sole discretion and are binding and final. Failure to comply with these rules will result in disqualification from this Sweepstakes.

2. <u>Eligibility</u>. The Sweepstakes is open only to legal U.S. residents within the continental United States who are 18 years of age or older as of Wednesday, Feb. 24, 2021. Employees of the Sponsor and Delaware North Companies, Inc. - Boston ("DNCB") and their respective parent companies, subsidiaries, and affiliates, and the officers, directors, agents, employees, advertising and promotion agencies and members of their immediate families (spouses, parents, children, and siblings and their spouses) of each of the foregoing are not eligible.

3. <u>How To Enter</u>. No Purchase Necessary. There is one (1) method of entry for the Sweepstakes. In order to participate, you must be a registered user on Twitter.com and follow @BostonProShop on Twitter. During the Sweepstakes Period, Sponsor will send a "tweet" from the handle @BostonProShop asking users to retweet (the "Sweepstakes Tweet") on Twitter.com. To enter, you must retweet the Sweepstakes Tweet using the retweet function within Twitter.com from your Twitter account during the Sweepstakes Period. An entry received outside of the Sweepstakes Period will be deemed ineligible.

To "follow" @BostonProShop on Twitter.com, log in to your Twitter account and select "Find People" from the tool bar at the top of the homepage. When the search box appears, enter "@BostonProShop" and then click on the "Search" button. Select "Follow" when the @BostonProShop icon appears.

Limit one (1) entry per person. Entries will not be acknowledged.

4. <u>Selection of Winner</u>. One (1) Winner will be selected from all eligible entries received during the Sweepstakes Period in a random drawing to be conducted within approximately three (3) days following the close of the Sweepstakes Period. The winner will be contacted via direct message on Twitter within that time frame. The Sponsor's decisions are final, binding, and conclusive on all matters related to the Sweepstakes. If the winner is not responsive within 24 hours of the initial notification, or in the event of non-compliance with any of these requirements, the prize will be forfeited and an alternate winner selected.
